## **Summary Annual Report for** RHODE ISLAND LABORERS ANNUITY FUND

This is a summary of the annual report for Rhode Island Laborers Annuity Fund, EIN 05-0417267, Plan Number 001, for the period January 1, 2024 to December 31, 2024. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## Basic Financial Statement

Benefits under the plan are provided by a trust. Total plan expenses were \$18,279,756. These expenses included \$723,267 in administrative expenses and \$17,556,489 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 9,546 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$253,272,131 as of December 31, 2024, compared to \$226,062,825 as of January 1, 2024. During the plan year the plan experienced a change in its net assets of \$27,209,306. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$45,489,062 which included employer contributions of \$25,832,973, employee contributions of \$0, other contributions of \$70,103, gain/loss of \$-1,408,423 from the sale of assets, and earnings from investments of \$20,994,409.
